Information Session-October 8, 2022

Please join us at the upcoming information session

The California High-Speed Rail Authority (Authority) invites you to attend the in-person information session for the Palmdale to Burbank Project Section. The Authority announced the availability of the Draft Environmental Impact Report/ Environmental Impact Statement (Draft EIR/EIS) for the Palmdale to Burbank Project Section. The Draft EIR/EIS is available for review and public comment at www.hsr.ca.gov. The comment period began on September 2, 2022, and ends on December 1, 2022. The Project Section is part of Phase 1 of the California High-Speed Rail System and connects the Antelope Valley to the San Fernando Valley. This approximately 31- to 38-milelong project section will connect two key population centers in Los Angeles County by linking future multimodal transportation hubs in Palmdale and Burbank.

The information session offers the public an overview of the environmental document, opportunity to review and ask questions and provide formal verbal testimony about the Draft EIR/EIS, and information on where to access the environmental document and how to participate in the public comment process. Project team members will be available to answer questions.

After the public comment period closes, the Authority will prepare a Final EIR/EIS, which will include responses to comments received during the comment period.

The Authority is also the lead agency under the California Environmental Quality Act (CEQA).
